

Waiver

I am aware of the dangers involve in participating in an obstacle course. I acknowledge, understand, and appreciate that as part of my or my child's participation in the Junior Adventure Challenge there are dangers hazards and inherent risks to which I or my child may be exposed, including the risk of serious physical injury, temporary or permanent disability, and death, as well as economic and property loss. I acknowledge that neither I nor my child are currently suffering from, nor have I or my child previously suffered from, any physical, medical and/or mental disability or condition which would preclude me or my child from participation in the Junior Adventure Challenge, or that would endanger me or my child or interfere with my ability to safely participate or my child's ability to safely participate in the same. I acknowledge and agree that is my responsibility to determine whether I or my child is sufficiently fit and healthy enough to safely participate in the Junior Adventure Challenge. Therefore, I voluntarily accept and assume all risk of injury, loss of life or damage to property arising out of training, preparing, participating and traveling to or from the Junior Adventure Challenge on behalf of myself and/or my child.
